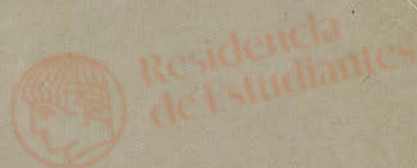
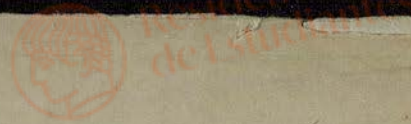


PEACE MAP OF EUROPE
