### FLASHBACK TO 1942

Clearing out a drawer the other day, Louis Claridge (Sales) came across a notice which we reproduce below:

## INVASION.

In the event of invasion, normal production will continue as long as possible, but priority over everything must be given to repelling the enemy. Civilians will be required for any duties they can reasonably undertake other than fighting.

The Bedford and Kempston Invasion Committees have decided to obtain the labour required for these duties through this firm and others in the district, and we have been requested to organise NOW. Civil Defence Workers and Home Guard will receive their orders from their authorities. All others available for duty, both male and female, may be required to perform tasks which are listed on the form attached. Please put a X against the job you feel you can best perform. The fact that you have put a X against a particular job will not necessarily guarantee that you will be given that work to do—it may be that you will have to be put on something else. When these forms are returned, you will be allocated for duty in a definite organised squad.

Bear in mind that if invasion occurs, and Defence Regulation 84AA operates you will be under compulsion to perform these duties under heavy penalties, so that organisation now is essential.

This Form is to be returned to us by May 15th, 1942.

If the enemy lands in England and we are to repel him, it is essential that **EVERYONE MUST DO SOMETHING USEFUL. DO NOT LURK AT HOME** wondering what is happening. Come immediately to the firm for your instructions. Your dependants should remain at home or with friends or relatives in the immediate vicinity until such time as you receive instructions from the authorities.
